#### 3.2. Sleeping in Clubhouse & on yachts ashore

**UPDATE 20240702**: JM emailed Ben Bennett (Insurance Broker) to ask about a) sleeping in clubhouse, b) sleeping in yachts ashore. His response is below:

As regards your query on sleeping on the premises, this would not cause any issue for insurers – on the strict proviso that all safeguarding policies/procedures are adhered to and any requirements of the authorities (i.e. fire) are met.

In terms of members sleeping on their own yachts (whether afloat or ashore), I would simply recommend that the Club are comfortable with the situation (you may want to seek advice/guidance on this from RYA legal) and, importantly, each member concerned must check with their boat insurer to ensure that this is permissible under the terms of their own individual policy. As you say, they do so at their own risk and it would be difficult to see a scenario whereby the Club could in any way be deemed liable in the event of an incident.

# 3.3. Norman Whitfield (AR / TC)

JM sent a recorded delivery letter to Norman about the arrears and what the GC had decided to do. He received an email from George Hartley who had opened the letter to inform him that Norman died on 28 May 2025 in a care home in Maidstone. JM has responded to the email (5 July 2024) to acknowledge it and has recommended that Adrian contact the Care Home to see if they have any family address. If there is none, then we have done our due diligence in trying to trace them, so we can go ahead with disposing of the assets. AR has sent letters on the 12/07/2024 and await a response. AR to send a further giving 3 month's notice of the clubs intention to dispose of assets to recover outstanding fees

# Dear Mr Pearce,

I hope this email finds you and your wife well.

Firstly, I would like to apologise for the delay in concluding this investigation into the wash report submitted by Mr Lambell on your behalf on 4<sup>th</sup> July 2024.

The findings of the investigation were as follows:

After ascertaining the time at which the allegated wash happened, the traffic recordings were used to determine which vessels had passed at the time of the event. The only identifiable vessels based on the description of the incident where the SD DOLPHIN and SONGA FALCON followed by BEAUMONT. While neither of the vessels were transiting at an excessive speed, the combined effects of the wash from all three vessels could have been significant enough to cause the incident.

The Master of the tug has been reminded to be mindful of his wash, especially when transiting in close proximity of other vessels where the combined effect of wash from various vessels might worsen the situation. I have also received confirmation from the tug operator that they will pass on this educational advice to other Masters to be mindful of the effects of their wash when operating on the Thames.

I would like to take this opportunity to advise you that you are able to make a report via telephone as well by calling our London VTS operations room which operates 24 hours per day/365 days per year on 01474 562215. Our VTS Officers can submit the report on your behalf and take any actions needed at the time. Proposal from Alan Cooper 22/07/2024

Dear All

The GC kindly approved purchase of a 5G cellular router at the last GC which I have tested.

My somewhat expert view having tested it on all services is that it would not be satisfactory or reliable enough for what we are looking for.

Therefore I returned it during the return period and will have re imbursed EYC with the cost.

Things are a little better in that I reported our service to BT and it seems a bit more reliable. But we will never I think get over the high cost of BT removing copper and installing fibre, which is their aim by end 2025. No probs if the infrastructure goes by your front door, but for us a special install at many £k's. Ducting etc. I can get a proper survey if you want but it will be £k's.

There is one more solution which I would like to try. 30 day return, no questions asked. We pay postage there and back. Starlink Business.

It sounds expensive at £96 per month, but that is no more than we pay for BT Business and their (special) ! service. I pay £45 for domestic at home with BT.

But there would be about £500 cost for satellite hardware and bits. All refundable if we send it back.

Good reviews on Starlink now. Just a thought or leave it as is.

"Elon Musk's SpaceX has been in the news frequently of late - and the service is improving all the time. The 'portability' feature makes it possible to deploy satellite internet elsewhere for a small monthly fee. Still, Starlink is best known for offering a solution to people living in areas outside the scope of high-speed broadband or fibre optic internet. True, such people can rely on a mobile data (4G or 5G) connection but this is usually very costly and not very reliable."

So in conclusion, I would like to try Starlink and apart from the initial hardware cost is no more annually than BT Business. I would need help putting the antenna on the roof, but I can try it temporary without doing that.

It is on 30 day return. I would have to pay initially as you can only order on Credit or Debit card, which we don't have. Then once we have an account I think the forums say you can change the payment method.

Or forget it, just carry on as we are with BT.

To Summarise

Alan's point is that BT are phasing out Copper Connections and replacing with Fibre Optic Cabling, They aim to complete this by the end of next year, which will effect our telephone and WiFi connections. Erith Yacht Club will need to plan for this eventuality. Alan explains the options as he see them as follows:

- Fibre Optic Installation by BT this is prohibitively expensive (£15,000.00) We could explore whether funding is available for not for profit organisations We could lay the cable from the club to the road ourselves Alan also points out that the current BT Package costs approx. £90/Month
- 2) Starlink Option has set up costs thought to be £500.00 then has running costs comparable to that we currently pay to BT £90/Month Approx.
- Mobile Phone 4G/5G Is thought to be Costly and not very reliable. The recent trial was not successful Caveats It was a short trial and not all Networks trialled

# It was Agreed that we would trial the Starlink Option
